ANIMAL IDENTIFICATION INUMBER (AIN)

In order to better assist with the Traceability Movement in the state of Florida we are requiring **all Market Steers, Lambs, Goats, & Swine** to record the AIN Tag ID Number on their entry form, this tag is typically assigned by the breeder. If your animal is missing this number they will not be Eligible to show at the Central Florida Fair. **If the Number below is to change at ANY given time before final check in you must notify the Fair immediately.**

Animal Identification Number (Scrapies, 840, RFID 840, or NUES Number)

***Mandatory Disclosure of Social Security Number or Federal ID Number- Federal Tax regulation requires the Central Florida Fair to obtain Social Security Numbers (SSN) or Taxpayer Identification Number (TIN) from every person to whom compensation is paid. SSN or TIN are maintained and used by the Central Florida Fair for the processing of payments due, and are reported to Federal and State agencies on forms required by law. The Central Florida Fair will not disclose any SSN or TIN without your consent to anyone outside the Central Florida Fair except as mandate by law. Failure to provide a SSN or TIN will result in denial of compensation.**

Failure to pass the DNA test forfeits all premiums and ineligibility to show at CFF in the future.
