Central Florida Fair Youth Livestock Programs General Rules & Regulations

Rule Interpretation

- Interpretation and Administration of these rules will be vested in the Youth Livestock Committee and their decision will be final. Any evidence of fraud coming to the attention of the Committee will be fully prosecuted of the law.

Entries

- Entry forms are available on the Central Florida Fair website; www.centralfloridafair.com or upon request from the: Central Florida Fair, Livestock Department, 4603 West Colonial Drive, Orlando, FL 32808, (407) 295-3247.
- All entries must be made on official entry forms or online with all information complete and accurate and accompanied by fees when applicable. All entries in the Youth Livestock Programs must be submitted via online system by the registration deadline.

Health Requirements

- A Florida Department of Agriculture State Inspector will be on the grounds to check-in all animals and accompanying papers. Animals are not to be unloaded without approval from the State Inspector on duty.
- Any violation of these rules will be grounds for disqualification of entry.
- Market animals will be required to follow the rules outlined in 5C-4- Admission of Animals for Exhibition found on the Florida Department of Agriculture Website or as set forth by the Livestock committee. Please note that the Livestock Committee rules may ask for requirements to exhibit that go beyond the FDACS requirements. Livestock Committees will not be able to require less than put in place by FDACS.
- ALL Breeding Beef, Goats, & ALL Sheep must be covered by an official Health Certificate issued by an accredited veterinarian, dated within 90 days of the exhibition date. NO EXCEPTIONS!
- Rabbits, Cavies, & Poultry DO NOT NEED A HEALTH CERTIFICATE!
- 2027 COMMERCIAL LAYING HENS NPIP will be up to the discretion of the health inspector!
- ALL Purebred Poultry is required to have NPIP! NPIP Testing will be available at Check In through the State Health Inspectors.

Premiums and Awards

- The Central Florida Fair reserves the right to alter premiums and awards, delete categories or change sponsorships.
- Premiums will be paid based on the judging reports, which must be signed by the show superintendent or clerk.
- Premiums will be mailed to the exhibitor at the address given on the official 2027 entry form. All Address Changes must be sent in writing to Jacki@centralfloridafair.com before April 2, 2027!
- If a Social Security number or Federal ID Number is not provided, the Central Florida Fair will not issue premium or sale checks.

Judges and Judging

- The decision of the judge will be final, and no appeal will be considered.
- Any exhibitor who interferes with the judging will be promptly excluded from competition; if after judging, the premiums awarded will be withheld.
- All animals must be present in the coop to be evaluated by the judge to receive premiums.

Exhibitor Tickets/Credentials/Admission

- Each exhibitor will be issued an official livestock exhibitor wristband to be worn for the duration of his or her respective check in date. Each exhibitor will be issued Ten (10) single day admission tickets (tickets will be given at check in) to be used. Please Note: All tickets will be single day admission tickets. Be sure to utilize your tickets to cover every day you are at the fair. No additional tickets will be issued.
- Livestock 11 day passes will be available for purchase for Central Florida Fair 4-H/FFA family members at the fair website (Limit 8 per family). Please note after January 31, 2027 these tickets will NOT be available for purchase and individual full priced entry tickets will be required.
- The Fair strongly encourages exhibitors to purchase advance discount tickets for those who send

tickets to their respective buyers. Tickets may be purchased online or in the Fair Office, prior to opening day.

- Buyers who PURCHASED AN ANIMAL(S) at the 2026 Central Florida Fair will receive an Invitation Letter from the Fair to purchase animals again along with two (2) Fair tickets.

Entrance to Fair and Parking

- All livestock exhibitors must enter the Livestock Gate and park in the designated parking lots outside of the fairgrounds. Vehicles parked in non-designated areas will be towed away at the owner's expense.
- All vehicles and trailers will be parked in a remote location adjacent to or near the livestock complex.

Liability for Loss or Theft

- The owner or custodian of property of any kind brought to the fairgrounds either for exhibit or for other purposes assumes, as a condition of its admission to the grounds, all risks and/or responsibility for its loss, damage or theft.
- The Central Florida Fair, its officers and employees cannot and will not accept responsibility and liability for any damage or injury resulting from theft, fire, the elements, accidents, or other conditions or causes, whether to exhibits, property of exhibitor, vehicles on the grounds and articles left therein, and any other property of any nature whatsoever.

General

- By application for entry to the Central Florida Fair, each exhibitor certifies that all exhibits are in accordance with the Rules & Regulations of the Central Florida Fair and that the exhibitor agrees to be governed by these rules.
- Only bona-fide Central Florida youth agricultural organizations or FFA members residing in/or attending schools in the following counties Brevard, Lake, Orange, Osceola, Seminole, and Volusia are eligible to enter.
- Exhibitors must meet grade level requirements and be active in a 2026-2027 youth agricultural organization (FFA or 4-H). The youth organization must be affiliated with a National Organization. "BREED" Associations DO NOT meet the requirements of the Central Florida Fair Youth Livestock Programs.
- Exhibitors must be enrolled in elementary or secondary school.
- Exhibitors must submit their Report Cards & Homeschooling Forms no later than February 3, 2027 via the Submission Link on the CFF Website. Link will be open January 1 for the SEMESTER 1 Report Cards. The first semester includes both 1st and 2nd nine weeks grades and semester exams if required, for the 2026-2027 school year. An official report card that exhibits grades for the preceding semester is the ONLY acceptable evidence allowed for entry. The Report Card must clearly state the Exhibitor's First & Last Name and School Name on it. Report Cards not submitted by deadline will deem the exhibitor ineligible to exhibit at the Central Florida Fair.
- Exhibitors shall conform to the following standards in academics (cumulative grades are not considered): For FINAL ENTRY, the exhibitor must have received a **2.0 UNWEIGHTED GRADE POINT AVERAGE FOR THE FIRST SEMESTER**. The first semester includes both 1st and 2nd nine weeks grades and semester exams if required, for the 2026-2027 school year. An official report card that exhibits grades for the preceding semester is the ONLY acceptable evidence allowed for entry. The Report Card must clearly state the Exhibitor's First & Last Name and School Name on it.
- Academic Exception forms must be completed by the Principal, Guidance Counselor, or County 4-H Agent. Academic Exception forms must be submitted via submission link no later than February 3, 2027.
- Any exhibitor, parent, advisor, teacher, leader, or other, who displays unprofessional behavior toward any member of the Fair Board, Fair Management, Livestock Committee, Graders, or Judges, may be just cause for the exhibitor and their animals to be disqualified and removed from the Fairgrounds. Exhibitors may also be barred from showing at future fairs. Each person is responsible for his or her own behavior.
- Animals are restricted to a designated area of the fairgrounds and must not be taken from this area. Violators are liable for any damage incurred by the owner or animal.

- Names and telephone numbers of qualified local veterinarians will be available at the Livestock office. Each exhibitor is responsible for any bills incurred.
- Only animals being entered and shown at the Central Florida Fair are permitted on the fairgrounds at any time.
- Personal pets (i.e. dogs, cats, reptiles, and rodents) are strictly prohibited on fairgrounds, with the exception to official Guide Dogs/ Leader Dogs for the Blind.
- The use of tobacco products, drugs and alcoholic beverages in the livestock complex is strictly prohibited.
- Smoking is strictly prohibited in the barn.
- Failure to maintain animals and exhibit to acceptable standards and/or failure to cooperate with Fair Officials may result in premium forfeiture. Any person who violates any of the General Rules or other rules as published in the 2027 Central Florida Fair Youth Livestock Premium Book will forfeit all privileges and premiums won.

Exhibitor Special Needs

- It is the responsibility of the exhibitor and a parent to inform Fair Management of special needs (i.e., hearing or physical disability) an exhibitor may have. Special arrangements cannot be made if Fair Management is not aware of the need.
- Exhibitors with an IEP need to provide an accommodation sheet if applicable via IEP Submission Link on our website by February 3, 2027.

Protests

- All protests must be made in writing, must plainly state the complaint, be accompanied by a deposit of \$50.00 (which will be forfeited if the protest is not sustained) and must be delivered to the management within 24 hours after the cause of protest. Judging Protests will not be entertained.

Attire (Official Central Florida Fair Show Ring Attire)

- Official dress for FFA is as defined in the official manual (note the comments below regarding shoes and pants). Skirts are not allowed.
- Youth exhibiting under 4-H must wear black pants (NO BLUE JEANS) with a belt, and shirts must be tucked in. Pant legs must be worn on the outside of the boot, and skinny jeans are not permitted.
- Exhibitors must wear a white, long-sleeve, button-down collared shirt.
- All 4-H exhibitors must have one of the following: an official 4-H jacket, a 4-H vest, or a 4-H emblem displayed on the white long-sleeve shirt.
- A green tie, bolo, or 4-H bow/ascot is required.
- Closed-toe brown or black boots that rise above the ankle must be worn. Athletic shoes (sneakers/tennis shoes) and boat shoes (such as Sperry's) are not acceptable; however, poultry exhibitors may wear solid black athletic shoes with official dress.
- No hats may be worn.

Camping

- All Campers/RV's must have a reserved camping spot through showworks in order to be allowed on the fairground's campground.
- Sites only have 30 & 50 amp availability. 50 Amp hook ups are limited, must be reserved ahead of time through the Fair Office.
- Campsites are located on the grounds at a rate of \$160.00 per week, per site. Sites include Water and Electric. A Pump Service will be available to schedule.
- Only self-contained units are allowed, NO TENTS! A limited number of spaces are available; therefore, reservations need to be made as early as possible. Reservations will be honored upon receipt of full payment, until available spaces are filled.
- Camping Availability is limited. First come, first serve. Campers will be located near the Livestock Pavilion.
- All camping reservations must be received by January 15, 2027. Any questions please contact Jacqueline Stough at (407) 295-3247 or Jacki@centralfloridafair.com
- All Livestock Camping Reservations will ONLY be done online. NO CHECKS will be accepted.

NATIONAL CODE OF SHOW RING ETHICS

IAFE (INTERNATIONAL ASSOCIATION OF FAIRS AND EXPOSITIONS)

Exhibitors of animals at livestock shows shall at all times conduct themselves with honesty and good sportsmanship.

Their conduct in this competitive environment shall always reflect the highest standards of honor and dignity to promote the advancement of agricultural education. This code applies to junior as well as open class exhibitors who compete in structured classes of competition. This code applies to all livestock offered in any event at a livestock show. In addition to the "IAFE National Code of Show Ring Ethics," fairs and livestock shows may have rules and regulations which they impose on the local, county, state, provincial and national levels.

All youth leaders working with junior exhibitors are under an affirmative responsibility to do more than avoid improper conduct or questionable acts. Their moral values must be so certain and positive that those younger and more pliable will be influenced by their fine example. Owners, exhibitors, fitters, trainers and absolutely responsible persons who violate the code of ethics will forfeit premiums, awards and auction proceeds and shall be prohibited from future exhibition in accordance with the rules adopted by the respective fairs and livestock shows. Exhibitors who violate this code of ethics demean the integrity of all livestock exhibitors and should be prohibited from competition at all livestock shows in the United States and Canada.

The following is a list of guidelines for all exhibitors and all livestock in competitive events:

1. All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
2. Owners, exhibitors, fitters, trainers, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
3. Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
4. Animals shall be presented to show events where they will enter the food chain free of drugs. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event, which culminates with the animal entering the food chain, shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal's performance or appearance at the event. If the laboratory report on the chemical analysis of saliva, urine, blood, or other sample taken from livestock indicates the presence of forbidden drugs or medication, this shall be prima facie evidence such substance has been administered to the animal either internally or externally. It is presumed that the sample of urine, saliva, blood, or other substance tested (by the approved laboratory to which it is sent) is the one taken from the animal in question. Its integrity is preserved and all procedures of said collection and preservation transfer to the laboratory and analysis of the sample are correct and accurate and the report received from the laboratory pertains to the sample taken from the animal in question and correctly reflects the condition of the animal at the time the sample

was taken, with the burden on the owner, exhibitor, fitter, trainer, or absolutely responsible person to prove otherwise at any hearing in regard to the matter conducted by the fair or livestock show. At any time after an animal arrives on the fair or livestock show premises, all treatments involving the use of drugs and/or medications shall be administered by a licensed veterinarian.

5. Any surgical procedure or injection of any foreign substance or drug or the external application of any substance (irritant, counterirritant, or similar substance) which could affect the animal's performance or alter its natural contour, conformation, or appearance, except external applications of substances to the hoofs or horns of animals which affect appearance only and except for surgical procedures performed by duly licensed veterinarian for the sole purpose of protecting the health of the animal, is prohibited.

6. The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.

7. Direct criticism or interference with the judge, fair, or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation, and respect and no person shall direct abusive or threatening conduct toward them.

8. No owner, exhibitor, fitter, trainer, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individual to disciplinary action.

9. The application of this code of ethics provides for absolute responsibility for an animal's condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.

10. The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have any disciplinary action taken by the fair or livestock show against such individuals published in any publication of the International Association of Fairs and Expositions, including Fairs and Expositions and any special notices to members.

11. The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE National Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.

5C-4.0015 Definitions.

For the purposes of this chapter, the definitions in Section 585.01, F.S., and the following shall apply:

- (1) Accredited tuberculosis-free herd. As defined in Rule 5C-3.001, F.A.C.
- (2) Accredited tuberculosis-free state or zone. As defined in Rule 5C-3.001, F.A.C.
- (3) Accredited veterinarian. As defined in Rule 5C-3.001, F.A.C.
- (4) Approved livestock facility. As defined in Rule 5C-3.001, F.A.C.
- (5) Authorized Representative. An employee of the state or federal government, or a licensed veterinarian accredited by the USDA, who is authorized to conduct animal disease control and eradication activities.
- (6) Certified brucellosis-free state or area. As defined in Rule 5C-3.001, F.A.C.
- (7) Certified brucellosis-free herd. As defined in Rule 5C-3.001, F.A.C.
- (8) Classified brucellosis-Class A state or area. As defined in Rule 5C-3.001, F.A.C.
- (9) Department. As defined in Rule 5C-3.001, F.A.C.
- (10) Electronic Official Certificates of Veterinary Inspection (ECVI). An electronic certificate provided by USDA Veterinary Services Process Streamlining System or a third-party vendor approved by the United States Animal Health Association (USAHA) ECVI Data Standards Subcommittee and issued by licensed and accredited veterinarians in animal's state of origin.
- (11) Exhibition. Any fair allowing the displaying or presenting livestock, including poultry, to the general public for an animal exhibit or animal show.
- (12) Fair(s). Annual public fair as defined in F.S. 616.001, that exhibits domestic animals.
- (13) Group. One or more Animals maintained on the same premises or in contact with one another.
- (14) Isolation. Separation of individual Animals by a physical barrier in a manner that assures one Animal does not have access to the body, excrement, or discharges of another Animal; does not share a building with a common ventilation system; and is not within ten feet of another Animal.
- (15) Market class. An exhibition class consisting of finished fed animals.
- (16) Official certificate of veterinary inspection (OCVI). As defined in Rule 5C-3.001, F.A.C.
- (17) Official individual identification. As defined in Rule 5C-3.001, F.A.C.
- (18) Official test. A test conducted by a licensed and accredited veterinarian with method approved by Department rules for the specific disease and animal species.
- (19) Owner. The owner of the animal or herd or the owner's authorized agent.
- (20) Pseudorabies. A contagious, infectious herpesvirus, causing communicable disease of livestock and other animals also known as Aujeszky's disease or mad itch.
- (21) Recognized slaughtering establishment. As defined in Rule 5C-3.001, F.A.C.
- (22) Swine brucellosis. An infectious bacterial disease caused by *Brucella suis* (B. suis) biovars 1 or 3, most frequently affecting swine but able to cause disease in other animals and humans.
- (23) Terminal swine show. An exhibition market class consisting of swine that are isolated and housed separately from all other animals and designated for slaughter only channels.

(24) Validated brucellosis-free herd, as defined in 9 CFR §78.1 (JAN 2024). This definition of validated brucellosis-free herd is hereby incorporated by reference and available online at <http://www.flrules.org/Gateway/reference.asp?No=Ref-17727>.

5C-4.0016 Applications, Cards, Forms, Other Official Documents Required and Fees.

(1) USDA. The Equine Infectious Anemia Laboratory Test VS Form 10-11 (DEC 2020), an USDA, Animal and Plant Health Inspection Service (APHIS), Veterinary Service (VS) form required for submitting samples and reporting results of Equine Infectious Anemia (EIA) tests. Equine Infectious Anemia Laboratory Test VS Form 10-11 (DEC 2020) , as incorporated in subsection 5C-18.001(10), F.A.C.

(2) OCVI. Florida-licensed and accredited veterinarians may obtain the following OCVIs through the department:

(a) Official Certificate of Veterinary Inspection, FDACS-09000 Rev. 06/17; for use with all species, in association with movement or sale. Cost is \$65 per book of 25 certificates. Official Certificate of Veterinary Inspection, FDACS-09000 Rev. 06/17 is incorporated by reference in Rule 5C-24.003, F.A.C.

(b) Official Equine Certificate of Veterinary Inspection, FDACS-09002 Rev. 04/17; for use with equine, in association with movement or sale. Cost is \$65 per book of 25 certificates. Official Equine Certificate of Veterinary Inspection, FDACS-09002 Rev. 04/17 is incorporated by reference in Rule 5C-24.003, F.A.C.

(c) Florida-licensed and accredited veterinarians may obtain OCVIs through electronic official certificates of veterinary inspection.

(3) Negative EIA Test Verification Card, FDACS-09160 Rev. 08/18, is an official document provided by the Department to the equine owner to show proof of a negative EIA test within the previous 12 months, for purposes other than change of ownership. The document is valid for 12 months from the date the blood was drawn and is renewable annually with an associated fee of \$5.00 per application (Card). The Negative EIA Test Verification Card may be applied for by submitting the Application for Negative EIA Test Verification Card, FDACS-09206 Rev. 10/05. Negative EIA Test Verification Card FDACS-09160 Rev. 08/18 is hereby incorporated by reference and can be found online at <http://www.flrules.org/Gateway/reference.asp?No=Ref-10037>. Application for Negative EIA Test Verification Card, FDACS-09206 Rev. 10/05 is hereby incorporated by reference and can be found online at <http://www.flrules.org/Gateway/reference.asp?No=Ref-10038>.

5C-4.0017 General Requirements, Exemptions and Limitations.

(1) OCVI Required. Animals presented for exhibition purposes in Florida, unless specifically exempted, must be accompanied by an OCVI.

(a) The OCVI must be complete including the breed, sex, and registration number and, if applicable, the official individual identification of each animal.

(b) Results of a specific test requirement or herd accreditation, certification or validation number for each animal must be recorded on the OCVI with the date of the test or herd accreditation, certification or validation.

(2) Expiration of Required OCVI.

(a) For Florida-origin animals, an OCVI is valid for 90 days from the date of issue; or until the expiration date of any required tests, whichever is the earliest date.

(b) For animals imported into Florida for exhibition purposes only, the OCVI is valid for 30 days.

(3) Inspection. Prior to immediate acceptance at an exhibition, all animals presented for exhibition must be made available for inspection by an authorized representative for:

(a) The required Official Individual Identification of the Animal; and

(b) Clinical signs of disease including, but not limited to: caseous lymphadenitis, blisters/ulcers around the mouth, nostrils, coronary band, pinkeye, pox, scabies, lice, ringworm, atrophic rhinitis, or multiple warts that are clearly visible; and

(c) Evidence of compliance with Animal tests and OCVI requirements, where required.

(4) Animals Rejected for Exhibition.

(a) Any Animal in noncompliance with Animal tests and OCVI requirements, or

(b) Any Animal not meeting the Official Individual Identification requirements, or

(c) Any animal which is suspected of having or showing clinical signs of dangerous transmissible, contagious or infectious disease on visual inspection, or any animal which is known to be exposed to such diseases must be:

1. Immediately withdrawn from exhibition and returned to the place of origin, or
2. Examined at the owner's expense, by a Florida-licensed accredited veterinarian who certifies by a signed, written statement, that the animal is free of dangerous transmissible, contagious or infectious diseases and pests. The accredited veterinarian's examination must take place within 24 hours of the initial inspection by the authorized representative.

5C-4.001 General Requirements and Limitations.

5C-4.002 Cattle or Bison.

(1) OCVI Required.

(a) Florida-origin cattle or bison moved for exhibition must be accompanied by an OCVI dated not more than 90 days prior to exhibition.

(b) Cattle or bison imported from other states for exhibition must be accompanied by an OCVI dated not more than 30 days prior to exhibition.

(2) Official Identification Required. All cattle or bison entered for exhibition purposes, including market class animals, must have an official individual identification. If the breed registry and brand or tattoo are used to complete the identification requirements, then the breed registry number and brand or tattoo must be listed on the OCVI accompanying the animal to exhibition.

(3) Testing Requirements.

(a) Tuberculosis.

1. Florida-origin cattle or bison may be entered for exhibition without a tuberculin test.

2. Dairy Cattle. Dairy cattle imported into Florida, may be entered for exhibition provided they have:

- a. a negative caudal fold tuberculin skin test within 60 days prior to the date of the exhibition, or;
- b. originate from an accredited tuberculosis-free herd in an accredited tuberculosis-free state or zone.

3. Beef Cattle. Beef cattle or bison imported into Florida may be entered for exhibition provided they have:

- a. a negative caudal fold tuberculin skin test within 60 days prior to the date of the exhibition or;
- b. originate from an accredited tuberculosis-free herd or state.

(b) Brucellosis.

1. Test Required. Cattle or bison, six (6) months of age or older, must have evidence of a negative brucellosis test within 30 days prior to the date of exhibition.

2. Exemption from Required Brucellosis Test.

- a. Steers and spayed heifers; and
- b. Cattle or bison originating from,

(I) a certified brucellosis-free herd. The OCVI must show the certified herd number and the date of the last herd certification test, or;

(II) a classified brucellosis-free state or area, or;

(III) Cattle or bison from non-quarantined herds originating from a classified brucellosis-Class A state or area provided that the cattle are under 18 months of age.

5C-4.003 Swine.

(1) OCVI Required.

(a) Florida origin swine must be accompanied by an OCVI dated not more than 90 days prior to presentation for exhibition.

(b) Swine imported for exhibition must comply with the importation requirements set forth in Rule 5C-3.007, F.A.C. An OCVI is required for exhibition and must be dated within 30 days of entry.

(2) Identification. All swine, entered for exhibition purposes, including market class swine in a terminal swine show, must have official individual identification.

(3) Tests or Certification Required for Swine.

(a) Swine Brucellosis.

1. Florida origin swine six (6) months of age or older must test negative on an official test for swine brucellosis within 90 days prior to exhibition, or;

2. Originate from a validated brucellosis-free herd, or;

3. Originate from a commercial production swine herd as defined in subsection 5C-21.002(11), F.A.C.

(b) Pseudorabies. Florida origin swine six (6) months of age or older must test negative on an official test for pseudorabies within 90 days prior to exhibition, or;

1. Originate from a qualified pseudorabies negative herd as defined in 9 CFR §85.1 (JAN 2024), which is incorporated by reference and available online at <http://www.flrules.org/Gateway/reference.asp?No=Ref-17888>, or ;

2. Originate from an approved commercial production swine herd as defined in Rule 5C-21.002, F.A.C.

(4) Exemptions.

(a) Market class swine for exhibition in a terminal swine show are exempt from the OCVI and testing requirements provided all animals in the terminal swine show are transported directly to a recognized slaughter establishment or approved livestock facility in designated slaughter channels, within 7 days of the show date. At the end of the terminal swine show, the swine owner(s) must ensure:

1. Swine are transported directly from the terminal swine show to the possession of a recognized slaughter establishment, within 7 days of the end of the show, or;

2. Swine are transported directly from the terminal swine show to the possession of an approved livestock facility in designated slaughter only channels, within 7 days of the show.

(b) Owners must maintain swine show records for a period of two (2) years. The records must include:

1. Official individual identification of each animal, and;

2. Individual or business name and contact phone number of the entity transporting the swine from the terminal swine show to the recognized slaughter or approved livestock facility, and;

3. The name, physical address and delivery date to the recognized slaughtering establishment, or approved livestock facility where the swine were delivered.

(c) All swine referenced in subsection 5C-4.003(4)(a), F.A.C., must be held in isolation and only commingled with other swine in slaughter channels until slaughtered.

5C-4.004 Poultry, Domestic Fowl or Ratites.

(1) OCVI Requirements.

(a) An OCVI is required for poultry, domestic fowl or ratites imported into Florida as specified per Rule 5C-3.012, F.A.C. An OCVI for entry into exhibition is required and must be dated within 30 days of entry or the animals must be inspected as provided in subsection 5C-4.0017(3), F.A.C.

(b) Florida origin poultry, domestic fowl or ratites presented for exhibition must be accompanied by an OCVI dated within 90 days prior to exhibition or must be inspected as provided in subsection 5C-4.0017(33), F.A.C.

(2) Test or Certification Required. All poultry or domestic fowl entered for exhibition must originate from Pullorum-Typhoid Clean flocks or hatcheries, as provided in 9 CFR §145 (Jan. 2018) and §147 (Jan. 2018), or have a negative pullorum-typhoid test within 90 days prior to exhibition. 9 CFR §145 (Jan. 2018) and §147 (JAN 2018) are hereby incorporated by reference and available online at <http://www.flrules.org/Gateway/reference.asp?No=Ref-10045>.

(a) Florida-origin goats or sheep presented for exhibition must be accompanied by an OCVI dated not more than 90 days prior to exhibition, except lamb or kids less than three months of age and accompanied by their dam.

(b) Goats or sheep imported into Florida for exhibition must requirements set forth in Rule 5C-3.005, F.A.C. An OCVI is required for entry into and Exhibition and must be dated within 30 days prior to entry.

(2) Identification. All goats or sheep entered for exhibition purposes must have official individual identification, except lambs or kids under three months of age accompanied by their dam that has official individual identification.

(3) Tests or Certification Required.

(a) All dairy goats imported into the state for exhibition purposes for no more than 30 days are exempted from the import testing requirements in subsection 5C-3.005(4), F.A.C., provided:

1. The animals originate from:

a. Accredited tuberculosis-free states or herds, and

b. Certified brucellosis-free herds or classified brucellosis-Class A states or areas.

2. The animals return to the state of origin within 30 days of entry into Florida, and

3. The animals' milk is not used for human or pet consumption in Florida.

(b) Dairy goats that remain in Florida for more than 30 days must meet the brucellosis and tuberculosis import testing requirements in the subsection 5C-3.005(4), F.A.C.

(c) There are no tuberculosis or brucellosis test requirements for meat type goats, pygmy goats, or Florida-origin dairy goats.

(a) Equine Infectious Anemia Laboratory Test, VS Form 10-11 (2020), as incorporated in subsection 5C-18.001(10), F.A.C.

(b) Negative EIA Test Verification Card, FDACS-09160 Rev. 08/18, as incorporated in subsection 5C-4.0016(3), F.A.C.

(c) EIA reporting form approved by the USDA and another state's animal health official, including electronic EIA laboratory test. An electronic EIA laboratory test may be presented on an electronic device if:

1. The electronic reporting form is in the original format and has not been altered, and

2. Is of size and image quality to provide a clear, legible document; and

3. The device properly displays all document information.

(3) Exemption to Test Requirement. A foal under six (6) months of age is not required to have a negative EIA test if it is accompanied by its dam which has met the EIA test requirement.

I understand that the 2027 Youth Livestock Programs are held in conjunction with the 2027 Central Florida Fair and agree that the Central Florida Fair is not liable or responsible for any delay, change of dates or cancellation of the 2027 Central Florida Fair due the following force majeure events: (a) acts of God; (b) flood, fire, earthquake; or (c) other potential disaster(s) or catastrophe(s), such as epidemics, or explosion.

Market Animal Backups:

Clubs/Chapters will be allowed ONE chapter/club market animal project, provided it is a Market Hen, Market Goat, Market Steer, Market Lamb, or Market Swine project. 1 Backup Market Animal will be allowed per Exhibitor. Each Market Exhibitor may register up to 2 market animals. Any Exhibitor who chooses to register animals in two separate Market categories will be required to designate 1 week prior to the Initial Weigh in/ Tagging/ Pick up which animal will be labeled as the Backup entry. Please note if we must do a drawing for any species Back up animals will be automatically dropped from registration. All Back up designations must be written on the back of the entry form. Exhibitors listed for cross species Back up animals must submit a record book and take required Skill A Thon for back up animal entries to be valid.

Market Animal Drawing:

In the case that more than the allotted number of animals is entered into this Market Program, The Central Florida Fair will initiate a Lottery system. Each of the 6 counties is given a specific amount of entries in accordance with their average number of entries for the last 5 years. Any Counties with 0 Entries during the Lottery System will have their slots divided by the counties entered in the drawing.

Alternate Exhibitors:

3 Alternate Exhibitors will be selected in the case of a Market Steer Drawing. These selected exhibitors will begin the Market Animal project with the same expectations, deadlines, and responsibilities as primary exhibitors. They complete all required activities—such as entry fees, tag-in or pick-up, report cards, Skill A Thon, and record books—so they are fully prepared if an exhibitor slot becomes available. Openings are filled in waitlist order and may occur at any point up to species Check-In. While alternates participate in the full project experience, placement in the show, showmanship, or sale is not guaranteed; if no primary exhibitor withdraws, the alternate completes the project without entering the Market Animal Show & Sale.

Chapter Animals:

All chapter animals registered under the chapter name will be entered online in the following format: First Name: Club Name & Last Name: Student's first and last name. Please note that all winnings from animals registered this way will be paid in full to the Chapter. All Chapter Animals will use the School's Tax ID Number and NOT The students Social Security Number. The only information on the entry that will belong to the student is their Date of Birth, grade, Ethics Number and parent contact information. All other information should belong to the school/ club.

Official Central Florida Fair Show Ring Attire:

Official dress for FFA is as defined in the official manual (note the comments below regarding shoes and pants). Youth exhibiting under 4-H must wear black pants (NO BLUE JEANS) with a belt, and shirts must be tucked in. Pant legs must be worn on the outside of the boot, and skinny jeans are not permitted. Exhibitors must wear a white, long-sleeve, button-down collared shirt. All 4-H exhibitors must have one of the following: an official 4-H jacket, a 4-H vest, or a 4-H emblem displayed on the white long-sleeve shirt. A green tie, bolo, or 4-H bow/ascot is required. Closed-toe brown or black boots that rise above the ankle must be worn. Athletic shoes (sneakers/tennis shoes) and boat shoes (such as Sperry's) are not acceptable; however, poultry exhibitors may wear solid black athletic shoes with official dress. No hats may be worn.

Definitions

Age divisions will be based on the exhibitor's age as of September 1, 2026.

Junior:	8 - 10
Intermediate:	11 - 13
Senior:	14 - high school graduation

It is the responsibility of the exhibitor and a parent to inform Fair Management of special needs (i.e., hearing or physical disability) an exhibitor may have. Exhibitors with an IEP need to provide an accommodation sheet if applicable via IEP Submission Link on our website by February 3, 2027.

All entries in this category shall be subject to the Central Florida Fair Youth Livestock General Rules and Regulations, the IAFE National Code of Show Ring Ethics and the Florida Department of Agriculture Animal Health Requirements as found in the front of this Premium Book.

Intent & Purpose

The intent of the Market Steer Program is to promote youth development through a meaningful experience, which will help young people develop into responsible adults. To promote competitive events where youth livestock projects help showcase the beef industry, where emphasis is placed on the educational aspects of the program including: selection, feeding, record keeping and showmanship. Steers should approach the goal of weighing approximately 1100-1250 pounds that will have a yield grade of two. Steers must be less than 32 months of age. A Steer is defined as a castrated male bovine.

Animal Eligibility, Exhibitor Eligibility, & Initial Tag-In

1. Only bona-fide **Central Florida** youth agricultural organizations or FFA members residing in/or attending schools in the following counties Brevard, Lake, Orange, Osceola, Seminole, and Volusia are eligible to enter.
2. Exhibitors must meet grade level requirements and be active in a 2026-2027 youth agricultural organization (FFA or 4-H). The youth organization must be affiliated with a National Organization. "BREED" Associations DO NOT meet the requirements of the Central Florida Fair Youth Livestock Programs.
3. Exhibitors must be enrolled in elementary or secondary school.
4. Exhibitors must submit their Report Cards & Homeschooling Forms no later than February 3, 2027 via the Submission Link on the CFF Website. Link will be open January 1 for the SEMESTER 1 Report Cards. The first semester includes both 1st and 2nd nine weeks grades

- and semester exams if required, for the 2026-2027 school year. An official report card that exhibits grades for the preceding semester is the **ONLY** acceptable evidence allowed for entry. The Report Card must clearly state the Exhibitor's First & Last Name and School Name on it. Report Cards not submitted by deadline will deem the exhibitor ineligible to exhibit at the Central Florida Fair.
5. Exhibitors shall conform to the following standards in academics (cumulative grades are not considered): For FINAL ENTRY the exhibitor must have received a **2.0 UNWEIGHTED GRADE POINT AVERAGE FOR THE FIRST SEMESTER**. The first semester includes both 1st and 2nd nine weeks grades and semester exams if required, for the 2026-2027 school year. An official report card that exhibits grades for the preceding semester is the **ONLY** acceptable evidence allowed for entry. The Report Card must clearly state the Exhibitor's First & Last Name and School Name on it.
 6. Academic Exception forms must be completed by the Principal, Guidance Counselor, or County 4-H Agent. Academic Exception forms must be submitted via submission link no later than February 3, 2027.
 7. Exhibitors must be under the direct supervision of their Leader/Advisor/Parent/Guardian while on property. Leaders **MUST** submit a Point of Contact Form for each species prior to check in.
 8. Exhibitors may sell one market livestock animal in the Central Florida Fair.
 9. Initial weigh-in Saturday, September 12, 2026 8am-11am.
 10. A Steer is defined as a castrated male bovine.
 11. Ownership date is Saturday, September 12, 2026.
 12. Documents required at weigh-in (provided by the Central Florida Fair Website):
 - a. Completed official entry form with signatures.
 - b. Bill of sale is required. Bill of Sale needs to include information such as breeder/ seller name, phone number, animal breed, birthday, identification number, 840 State ID, etc.
 - c. Exhibitors entering Orange County Born Steer **MUST** bring Breeders Affidavit.
 13. Exhibitors may register two (2) steers at the time of Registration. The Central Florida Fair will only accept one (1) steer per registered exhibitor at the Final Weigh in.
 14. Clubs/Chapters may enter a backup steer for their exhibitors who have already registered an animal. The club leader must provide a list of eligible market exhibitors who are able to show this animal if necessary. See Page 14 for details on Back Up Animals.
 15. \$15 entry fee required at time of online entry. Plus \$2 online service charge.
 16. Market Steer will be assigned a Central Florida Fair sale ear tag at initial tag-in and it must not be removed.
 17. Any Exhibitors whose ear tag falls out must contact the Chair, Co-Chair or Fair Office within 24 hours of the tag falling out.
 18. Any Exhibitors whose animal's ear tag does not match that of initial tag in numbers will be fined \$50.00.
 19. All Steers must follow all USDA Official requirements. Official ID on the animal must Correspond with information on the Health Certificate.
 20. Exhibitors must designate at time of online entry which agricultural organization (4-H/FFA/etc.) they will conduct their project. No exhibitor will be allowed to change organizations after Initial Weigh in/ Tag In.
 21. Participants in the Market Steer Program must be 8 years of age by September 1, 2026.
 22. The Steer Committee has recommended that steers weigh a minimum of 600 pounds on

Saturday, September 12, 2026. However, they will accept steers that weigh 550 pounds with a signed contract, understanding that the animal may not make the final weigh in weight of 1000 pounds. This contract will be signed by the exhibitor, parent/guardian and the leader/advisor. No protests will be entertained.

23. All steers should be dehorned prior to the initial weigh in Saturday, September 12, 2026. At the time of the initial weigh in, any exhibitor with a steer not properly dehorned must sign a contract affirming within 30 days to dehorn the steer. At Final Weigh in, any steer with greater than one (1) inch of horn beyond the hairline will be sifted.
24. It is mandatory each steer have a halter and lead rope on before they are unloaded.
25. DNA (tail hair, Etc) samples will be taken on each steer at initial Weigh in. IF any steer identity in question of not being the exhibitor's initial steer checked in, DNA Sample will be sent off for testing. Parent/guardian signature will be required on registration forms. Failure to pass the DNA test forfeits all premiums and ineligibility to show at CFF indefinitely. Exhibitor will be required to incur the cost of the DNA testing if the test results are returned confirming that the animal isn't the original animal tagged in.

Youth Livestock Show Ethics and Animal Care Workshop (MANDATORY)

The Central Florida Fair believes that every youth exhibitor should receive proper training and information for raising and showing a youth animal project. All exhibitors that exhibit at the 2027 Central Florida Fair must have completed the Ethics training in order to show at the 2027 Central Florida Fair. It is important that the exhibitors understand:

- The purpose of youth livestock projects
- The importance of ethics in youth livestock projects
- Proper animal handling and management
- The difference between animal welfare and animal rights
- Be prepared to be an ambassador for animal agriculture

The Youth Livestock Show Ethics and Animal Care Workshop is designed to certify students to meet the mandatory certification requirements that will be in effect for the 2027 Central Florida Fair. Certifications are valid for three (3) Fair seasons, not 3 calendar years. **For the 2026/2027 Fair Season, Certification Numbers starting with 25, 26 and 27 are current and valid.**

The requirements are as follows:

1. All exhibitors that are entered in the 2027 Central Florida Fair Youth Livestock Programs **MUST HAVE COMPLETED** the ethics training to show an animal at the 2027 Central Florida Fair.
2. Exhibitors in good standing with a current ethics certification do not need to attend. Please make sure you are current with your certification, and you will not expire prior to the 2027 Central Florida Fair.
3. The Central Florida Fair will host Two (2) dates for the Workshop at the Central Florida Fairgrounds. Additional workshops will be offered around the state. Check the Florida State Fair website for locations, dates and times www.floridastatefair.com

Record Books (MANDATORY)

1. All species are required to submit COMPLETED Record Books to the Fair Office no later than February 8. Record Books may be mailed to the address located on the front of the Premium Book with Attention to Jacqueline Stough. If mailing your Record Book, it must be received by February 8 to be accepted. Species include Breeding Ewe, Meat Doe, Breeding Beef, Market Goats, Purebred Poultry, Commercial Laying Hens, Rabbit, Market Steer, Market Swine, Market Lamb, and Cavy. All Record Books must be completed through the animals Check In date. The Fair is not liable for any submission lost by the Postal Service. It is the exhibitor's responsibility to confirm that the Fair has received their Record Books.
2. Only the 2027 Central Florida Fair Market record book will be accepted. Record Books can be found on the Central Florida Fair Website.
3. Record Books will not be accepted without the completed Signature Pages. Record books will be reviewed and any exhibitor submitting an incomplete record book will RECEIVE A ZERO AND will be notified along with their Leader/ Advisor. The exhibitor along with a parent or advisor will be required to complete the record book at final check in to be eligible for show and participation at the Central Florida Fair. The exhibitor will be given a 2-hour window to complete & resubmit on final check in day. Any record book deemed incomplete at resubmission will forfeit the exhibitor from participation & show at the Central Florida Fair.
4. The project officially begins Saturday, September 12, 2026.
5. All Market exhibitors are required to submit a copy of 1 buyer letter and provide a list of 5 buyers they have sent the letter to; 2 may be buyers from previous sales, 3 must have not bought in the past 2 years. For a Buyers list for 2025 & 2026 Fairs please contact Jacki@centralfloridafair.com or Visit the Central Florida Fair Website.
6. All Photos must be in color and from the current project year.
7. Record books not submitted by the deadline will result in exhibitor disqualification from the program.
8. Each exhibitor is expected to complete and submit an original record book that accurately reflects their own project experience and work. If it is determined that any portion of a record book has been copied, duplicated, or substantially reproduced from another exhibitor's record book or from a previously submitted record book, the record book will be disqualified and will receive a score of zero (0). The only exception to this policy is the Beginning Project Inventory. Exhibitors are expected to carry forward the ending inventory from the previous year's record book as the beginning inventory for the current year's project. This transfer of inventory information is required and will not be considered copying.
9. Record books must be complete at the time of submission. Parents and advisors/leaders are responsible for reviewing for completeness prior to signing.
10. Disqualified exhibitors will be notified by The Central Florida Fair.
11. Final Record Books must be handwritten by the exhibitor in their own words. Failure to comply is considered grounds for disqualification of the exhibitor resulting in ineligibility for show & participation in the Market Steer Program.
12. If additional pages are needed, print a duplicate page, and add them into the book. Be sure to staple in the left-hand corner & include them in your final calculations.
13. Graded record books will be returned at the Fair.
14. Exhibitors must score 70 or better to receive record book recognition and/or awards.
15. Exhibitors will be in age divisions; junior, intermediate and senior.

3. Exhibitors will be tested on Age Division appropriate material outlined by the Skill A Thon manual.
4. All exhibitors are required to participate in the Skill A Thon in order to show.
5. Failure to take the Skill A Thon will result in disqualification from the program.
6. Any Exhibitor unable to attend Skill A Thon must request in writing to the Livestock Manager at least 48 hours prior to Skill A Thon to be placed on the Make-up Testing List. Exhibitors must include their name, club, species, and reason for needing to be placed on the List. Placement on the list is up to the discretion of the Livestock Manager only. Record books will be accepted through Monday, February 8, 2027. Record books must be submitted to the Fair Office by Monday, February 8, 2027. Exhibitors are permitted to have others submit items or they can turn them in early to the Fair office, by appointment only! Anything not collected by the deadline will result in the exhibitor being ineligible to show at the 2027 Central Florida Fair.
7. There is no time limit during the multiple choice section of the test; however there may be time limits on the hands on station to ensure movement.
8. Exhibitors must score 70 or better to receive Skill A Thon recognition and/or awards.
9. Exhibitors will be in age divisions; junior, intermediate and senior.

Marketing Presentation Video (OPTIONAL)

2. Topic of Marketing Presentation Video is "Why Should you come to the 2027 Central Florida Fair to purchase My Market Project?" Exhibitors must focus on reasons for purchasing their projects. Remember to stick with information on your project and stray from information about factory farming and other items, advocate not scare.
3. Exhibitors must present a minimum of 3 reasons that a buyer should purchase your Market animal. Ensure that the reasons are clear enough for the judge and/or Buyer to find.
4. Exhibitors must compose an original video based on their own research. The focus of the video should be on the Marketing of your Market project. Be sure to include your introduction; your name, club, what species you're exhibiting, Ear tag number, show & sale dates, etc.
5. Assistance in recording the Marketing Presentation is allowed.
6. Exhibitors MUST use their animal in the video. Originality, Quality, Creativity, and Attractiveness is a big portion of your Points, along with tone, eye contact, dress, hand motions, etc.
7. The exhibitor must be in the live video and the judges visually able to see them throughout the entire presentation. No PowerPoint style videos.
8. There will be a maximum of 5 photos allowed to be edited into the videos.
9. Length of Marketing Presentation Videos will be 2-4 minutes.
10. Exhibitors are required to be in Official Show Attire for the duration of the presentation.
11. Since all videos will be judged prior to the Fair, all video registration forms with video link must be submitted on or before January 27, 2027. There will be no deadline extensions.
12. Students will fill out a Google Forms with a link to their video. All videos will need to be uploaded on or before January 27, 2027. Please Note: Videos on DVD or CD will not be accepted!!! Please keep the video open on YouTube until the end of April.
13. The Central Florida Fair will have the right to publish any video.
14. Failure to adhere to the rules may result in disqualification.
15. Exhibitors must score 70 or better to receive recognition and/or awards.
16. Points will be earned towards the champion exhibitor. Exhibitors receiving a zero will forfeit competing for Champion Exhibitor.

Care of Animal and Quarters during the Fair

1. Exhibitors are required to maintain clean and attractive quarters for his or her animal **at all times**.
2. Animals must be fed, watered and have their respective beds/pens cleaned daily.
3. No Hay Bags are allowed.
4. Feed is allowed in the pens during the days given there is someone supervising the animal.
5. All buckets must be removed from the animal bed by 10 P.M.
6. Outside tie outs must be cleaned by 10 AM.
7. Exhibitors must provide feed and all supplies, grooming equipment, brooms, neckties, wheelbarrows, etc.
8. Each exhibitor must provide feed for his/her own animal each day until the night of the sale.
9. The Central Florida Fair will provide bedding. Additional bedding is the responsibility of the exhibitor.

10. An adult, Leader or supervisor must be on Fair Property during Fair operation Hours. Each club/School will complete a Point Of Contact Form.
11. If someone is caring for your animals, please notify the Livestock office, Chair, or Co- Chairman immediately of the Exhibitor and what they are responsible for.
12. Leaders and Advisors will be notified if animals are not properly attended. Failure to do so will result in a possible fine of \$100.00 per occurrence. The money will be deducted from the gross receipts of the sale of the exhibitor's animal and put into the Youth Market Livestock account.
13. Barn is open from 7am to 10pm daily. All Animals must be cared for Daily and before 9am and after 9pm. Exhibitors are permitted to leave property after their animals are cared for and secured for the night. Please note that Herdsman judging does continue until Barn Close. The Herdsman Rubric can be found under the Herdsman section of this book.
14. No Animals are to be left unattended in Grooming Chutes.
15. Oral medication (drench, paste or tubing) must be brought to the committee for approval before and must be administered in the presence of a committee member. This includes electrolytes.

Final Weigh-in/ Fair

Wednesday, March 10, 2027 9-11 AM

1. All Market Steers are required to weigh-in at a minimum of 1000 pounds must have an average daily weight gain of at least 1.75 pounds per day from Initial Weigh in.
2. Steers must be less than 32 months of age at final weigh in.
3. Each animal will have the opportunity to weigh once for final weigh-in.
4. All animals must follow all USDA Official requirements. Official ID on the animal must Correspond with information on the Health Certificate.
5. Animals not checked in for exhibition are not allowed on the property without clearance from the Livestock Manager and the Health inspector.
6. Exhibitors must show their own animal in the show. In the case of sickness or school testing, approval must be obtained from Livestock Manager & the Steer Committee; a written request must be submitted prior to skill a thon. The request must include the reason for absence, name of the exhibitor. All Absences will be put to Committee Ruling, all decisions are final.
7. Tampering with the structural confirmation of an animal or filling with a foreign substance to alter weight, confirmation, or behavior is strictly prohibited.
8. EXHIBITORS ARE REQUIRED TO DEMONSTRATE THEIR ABILITY TO SAFELY CONTROL THEIR ANIMALS. After all animals are checked in, a parade at 7pm will be held from the assigned area, through the show ring, set up, and back to the assigned area. Each exhibitor shall untie parade and re-secure their animal without assistance. The Cattle Barn will remain closed for the Duration of the Control Parade.
9. At the time of sifting, the committee chairman will give reasons as to why an animal is rejected. Animals disqualified for any reason will not participate in the show or sale. All disqualified or sifted animals must be removed from the fairgrounds immediately.
10. Animals/ Exhibitors may be sifted at anytime due to any circumstance IE) structural conformity, behavior, malnourishment, etc.
11. Any Exhibitor dismissed for Behavioral or Ethical reasons will be restricted from showing at the Central Florida Fair for a minimum of 1 year.
12. Any Animal/Exhibitor that is rejected after initial entry into the Fair for any reasons and are dismissed from the property will be required to produce a valid OCVI (Health Certificate). Exhibitors who are dismissed are required to cover all Veterinarian costs incurred from the dismissal.

13. All Steer Exhibitors and a Parent Or Advisor/Leader must physically attend the mandatory exhibitor meeting at Final Weigh in, Wednesday, March 10, 2027 at 12pm. No exceptions.
14. Steer exhibitors MAY NOT remove any equipment or tear down their exhibits until after the completion of the FINAL livestock sale/auction!
15. It is mandatory each steer have a halter and lead rope on before they are unloaded.
16. All steers must be halter broke and kept under control by the exhibitor. Each steer must be kept tied securely with a halter and neck tie at all times when unattended.
17. Exhibitors are permitted to clip and fit with product however no glitter is permitted. Products must be made for use on Livestock and then used per manufacturer's directions. Products must have the original manufacturer's directions on the product. Committee members have the right to question products being used. All hair must be cleaned and removed from the clipping area. Each exhibitor will be allowed 1 designated person, 2 hrs prior to the start of the show to help exhibitors in preparation for the Show. Exhibitors MUST be actively involved in the preparation process. Professionals, Advisors/Leaders, and parents/guardians helping in any way are strictly prohibited and will result in a \$100.00 fine unless you are the designated person inside the allowed time. Exhibitors are still encouraged to help one another at all times.
18. All animals MUST be broken down and be free of adhesive and paint product prior to Barn Closure at 10pm. Failure to comply with rules will result in a \$100.00 fine and may result in disqualification from the Market Steer Program.
19. Any animals that are checked in with any Controlling Mechanisms IE nose ring, Cable Halter, etc must be used for the duration of the Fair. Exhibitors are only allowed to remove these devices when the animals are tied with neckties in the beds or in the outside tie outs. Any Exhibitor wishing to no longer use Controlling Mechanisms after check in must be reevaluated by the Committee.
20. Steer exhibitors MAY NOT remove any equipment or tear down their exhibits until after the completion of the FINAL livestock sale/auction! There will be a \$100.00 fine imposed on any and all exhibitors removing ANY items out of the livestock barn. This fine will be deducted from your sale checks!

Tack Space

Tack Space will consist of tack boxes, brooms, shovels, rakes, chairs, hoses, feed buckets, etc. An educational façade may be included in the tack space provided it meets the following criteria:

1. All Clubs will have a designated tack/Chute Space.
2. Club Leaders will submit a Chute Request form and submit it no later than January 20, 2027.
3. Chute numbers will be emailed to the leader/advisor after registration closes. Allotted chutes will be determined based on space availability and number of animals.
4. Tack boxes must be no taller than 6 foot high, and no longer than 5 foot, in order to fit into the designated tack spaces.
5. Cable will be provided and strongly recommend for signs. No signs to be hung from yellow divider rails.
6. Educational information highlighting the exhibitor's livestock projects.
7. Side panels are strongly recommended to separate the animals and the tack space. These structures may be the likes of livestock panels, fencing, etc. If fencing is used it should be no more than 4 feet high.
8. Fans and Fan holders with Safety Cages and guards may be used, but not in the public walkway areas.
9. No Chute set up until after the exhibitor meeting.

10. Chutes must be labeled with an appropriate sticker from the Livestock Office.

For safety reasons, no overhead structures will be allowed over the animals or over tack spaces. No additional flooring will be added to the tack space (ie; platforms, raised porches, wood paneling, etc.). The only acceptable flooring will be indoor/outdoor carpet in the tack space. No benches, chairs or structures of any kind will be allowed in the public or animal walkways.

Tack setup will be Tuesday, March 9, 2027 between 4-7pm. If no tack is set up before check in Exhibitors must wait until the barn reopens to load in tack.

Youth Market Steer Herdsman

Proper herdsmanship will be upheld by all exhibitors of the Central Florida Fair. In order to ensure a proper and safe environment for our exhibits, public guests and exhibitors, all exhibitors will be in participation of the Herdsman Contest during their time at the 2027 Central Florida Fair. Clubs will be separated into large and small groups for this contest. Groups will be judged based on numbers and will be decided at the final weigh-In of the fair.

The exhibits will be judged daily from 10:00 AM until 10:00 PM on the following basis:

1. Grooming chute and Outside tie out areas will be judged as part of the herdsman award.
2. Orderliness and cleanliness of service areas, pens, beds, wash areas, & animals and public walkways.
3. Neatness, courtesy and behavior of exhibitors.
4. Cooperation with fellow exhibitors and show officials in presenting attractive exhibits.
5. Availability of exhibitor to furnish information about their exhibits.
6. 1 Exhibitor must be present at all times; Caring for animals, up keeping the cleanliness of the area, and speaking with the public.
7. Exhibitors must have a Sign posted above their Pens listing the Exhibitor Name & School/ Club. Signs must be no bigger than 18" X 24". Any signage must be hung at head of animal.

2. The fitting contest is for fun and education! Three overall winning teams will be selected as the Fitting Contest Winners and will receive recognition in the form of a prize.
3. All participants may compete in one fitting and grooming team.
4. Animals should not be fitted and groomed prior to the contest.
5. Exhibitors will form teams of no more than 3. Max of 2 Seniors. Max of 2 Exhibitors from the same Club/ Chapter.
6. Arrive early to the contest and have your equipment ready. Once the contest starts, you may not leave the area or you will be disqualified.
7. Absolutely no coaching from spectators.
8. NO adults will be allowed in the arena during the contest except for the Judge and the Superintendents.

Prospect Steer Division

1. Prospect Steers will register November 16, 2026 through January 15, 2027.
2. Steers in the Prospect Steer Division are not required to obtain CFF Tags to be eligible.
3. The Prospect Steer Division is a Non-Terminal Division of the Market Steer Program.
4. Prospect Steers are exempt from the Record Book Requirement.
5. Prospect Steers will check in on March 10, 2027 9-11am.
6. All prospect steers must be castrated and fully healed prior to arrival on the grounds. Any steer exhibiting open wounds, scabs, excessive swelling, or unhealed tissue as a result of castration will be disqualified and not allowed to show. It is the exhibitor's responsibility to ensure that castration is performed early enough for complete healing before the show.
7. All steers will be shown by weight. Steer must be weaned.
8. Steers can be a maximum of 800 lbs.
9. Steers must have a health certificate.
10. An exhibitor can only show a maximum of 1 steer in this division.
11. Prospect steers may not be used in showmanship.
12. Grand and reserve will be the awards for this division.
13. You must have a market animal to be eligible in this division.

Market Steer Showmanship

The main objective in being a good showman is to present the animals to the livestock judge in the best possible manner. The animal must be set up properly, clean and trained well enough to respond to the exhibitor's commands. The exhibitor will be courteous, attentive (keep their eyes on the judge) and demonstrate knowledge of their project.

1. Steer Barn will close at 1:30 pm to ensure a safe and smooth show. Only Show personal and Staff will be allowed in after the barn closes. Any parent/ Leader/ Advisor wishing to stay with a child for Safety Reasons must be cleared through the Committee Chair or Co Chair 24 hours before the show.
2. Exhibitors will be placed in age divisions
3. Exhibitors must exhibit their own animal registered in the show.
4. Official dress is required. Official Dress Check Will is at 1:45 PM in the Center Arena.
5. Exhibitors are permitted to clip. All hair must be cleaned up in the clipping area and only other exhibitors may assist. Professionals, Advisors/Leaders and parents/guardians helping in anyway is strictly prohibited and will result in a \$100.00 fine.
6. Awards will be given to the top three places in each division.
7. Exhibitor earns points towards champion exhibitor (no monetary premium will be paid).

1st place in each Age Division -Belt Buckle
2nd place in each Age Division – Award
3rd place in each Age Division –Award

Senior Speeches

1. Any Senior wishing to give a speech will be required to sign up no later than end of day at Check-in.
2. Senior Speeches will be before Showmanship and/or Show begins. The order will be posted for Exhibitors.
3. Speeches are to be a maximum of 2 minutes, a 30 second warning will be given to each Senior.

1. Awards begin at 10am. Exhibitors are to stay in the arena until they are dismissed after announcements.
2. ALL Exhibitors are required to be in official Dress & present for Awards.
3. Failure to comply will result in the Exhibitors' loss of Premiums & the ability to show in the 2028 Central Florida Fair. Only exceptions may be provided by the Livestock manager, Chair, or Co-Chair.

Market Steer Sale

Sunday, March 14, 2027 at 2:00 PM

1. Market Steer Sale will be Sunday, March 14, 2027, starting at 2:00 PM with Market Goat, Market Lamb, Steers, a 15 minute intermission then completing the sale with Market Swine.
2. There will be no product permitted on any animal during Sale Day.
3. Exhibitors must be in official Central Florida Fair Show Ring Attire, this will be strictly enforced.
4. All Exhibitors Must Be Present for Market Sale.
5. Exhibitors must be in the arena 15 minutes prior to the sale starting for an Official Dress Check.
6. A four percent (4%) sales commission will be deducted from the sale price of each animal to cover the sale expenses.
7. This is a TERMINAL LIVESTOCK AUCTION...ALL ANIMALS will go directly to an approved, licensed slaughter facility. The Fair has contracted with processors, and ONLY those processors will provide transportation of these animals to their facility. NO OTHER TRANSPORTATION IS ALLOWED. NO EXCEPTIONS WILL BE GRANTED.
8. No animal may leave the fairgrounds without a release paper from the livestock office.
9. Removal of ear tags is strictly prohibited. Ear tags are to be left in the all animals for purposes of identification at load out and at the slaughter facility
10. Add ons will be accepted the day of sale at check out ONLY.
11. Any animal sold at the auction and condemned at slaughter by a State Inspector will be the financial responsibility of the exhibitor. The sale money will be forfeited by the exhibitor and the buyer will be refunded by the Central Florida Fair.
12. Steer exhibitors MAY NOT remove any equipment or tear down their exhibits until after the completion of the FINAL livestock sale/auction! There will be a \$100.00 fine imposed on any and all exhibitors removing ANY items out of the livestock barn. This fine will be deducted from your sale checks!

1. Buyer Thank You Letters are due by April 2, 2027.
2. ALL Market Exhibitors are required to submit a formal, typed, business thank you letter to their respective buyers and for any Add Ons they may receive. Please see Central Florida Fair's website for examples of acceptable Thank You Letters & Formatting.

5. Any Thank You letter received in an improper format will not be considered received until sent in the correct format. Exhibitors will receive a confirmation from the fair once they have

- received their letter and it has been accepted. IF YOU DO NOT RECEIVE CONFIRMATION WITHIN 1 BUSINESS DAY PLEASE REACH OUT TO THE FAIR ABOUT YOUR STATUS!
6. Thank You Letters NOT received by April 2, 2027 will be subject to a \$20 per day fine, which will be deducted from the exhibitors sale check.
 7. If NO Thank You Letter is received by April 9, 2027 the exhibitor will forfeit half of the remaining balance of their sale profits and the exhibitor will be suspended from showing/participating in ANY LIVESTOCK program at the Central Florida Fair for one year. NO EXCEPTIONS!
 8. Premium and Sale checks take six (6) weeks to process and will be mailed to the address provided on the Exhibitors' initial entry form. You have until April 2, 2027 to submit an address change via email.
